ARE YOU TOTTENHAM IN DISGUISE?

JULIAN HARRIS REPORTS ON SUMMER FROLICS AND WIDESPREAD RELIEF THAT THE FINAL ASHBURTON GROVE DECISION IS SOON TO BE TAKEN



Whilst most footy fans took a rest over the summer AISA has been busier than David Dein and the Arsenal credit card, organising support for the Ashburton Grove plans, and especially in countering the noise of the highly organised "residents" group who want to see Arsenal out of Islington.

What could be called the semi-final, the last consultation meeting before the decision-making Council, took place at the Union Chapel in Upper Street on July 24.

Whilst thousands (well, two hundred actually) of the opposition marched

down Holloway Road, we cunningly arrived at the venue early, ensuring we had the best places for the fight of the century. If only entry to Arsenal matches was so easy!

The moaning residents arrived at the venue with their loudspeakers, only to be outchanted by us gooners. Their 'Dump the Dump' came a poor second to our 'Are you Tottenham in disguise?' as we warmed up for the real thing.

The match itself was a stormer. The referee, sorry chairman, Councillor James Kempton, changed the debating rules before we started, but our team was well-prepared (too

well-prepared, moaned the moaners, unused to any opposition on their home ground).

Appropriately fourteen men and women spoke in favour of the Ashburton Grove plans (i.e the first team and three substitutes) led by AISA officers, Steven Powell and Paul Matz, and also including Bernard Azulay, Rab Bennetts, Amy Lawrence, Graham Stone, Tony Ward and local Eastender actress, Carinne Skinner-Carter.

The many councillors in attendance couldn't fail to be impressed as we now move on to the really BIG one – the Council meeting that will make the decision on whether our new 60,000 stadium gets the go ahead.

Just in case you think it's a done deal can I stress to you that it really is "up for grabs now", to quote the late-lamented Brian Moore. With just a few weeks before this cup final now is the time for you to show your

twenty years or so that the money in football has attracted lots of people from outside the game. Some of these people, in other clubs, have been very dodgy. As far as Arsenal goes it has a slightly unusual company structure. It's not listed on either of the two main stock exchanges, the London Stock Exchange or the Alternative Investment Market. The public can buy shares in Arsenal though through something called OFFEX, which is a market for shares in unlisted companies.

A TRUST WILL ALLOW SHAREHOLDERS TO POOL THEIR VOTING STRENGTH TOGETHER TO FORM AN INFLUENTIAL GROUPING

There are just over 61,000 issued shares at Arsenal, including the new shares recently bought by the media group Granada, which now owns 9.9% of the issued shares at Highbury. If you look at the Arsenal shareholders' register you'll see that,

aside from the big shareholdings of Danny Fitzman and David Dein which all Arsenal supporters know about, there are nearly 1,500 shareholders in total, many owning one or two shares.

Most of these will be supporters who've bought a share not as an investment but so that they can own part of the Club they love. A Trust would allow current shareholders to pool their voting strength together to form an influential grouping. It would also allow supporters who don't own shares at the moment to buy into ownership at an affordable price.

Many of us can't afford over £2,000, which is what an Arsenal share is quoted at currently. Fans feel that they own the club 'morally' – they built the traditions over the generations and made it the club that is it and make it special, so why not turn that moral ownership into something more concrete?

There's been a tendency to see supporter-ownership as something

for smaller clubs in financial trouble. I think that's a big mistake. Most Gooners I know are, like me, broadly happy with the current regime. Whilst I don't agree with everything the Board does we could do an awful lot worse.

FANS FEEL THAT THEY OWN THE CLUB 'MORALLY' . . . SO WHY NOT TURN THAT MORAL OWNERSHIP INTO SOMETHING MORE CONCRETE?

The problem is that there's nothing legally to stop the current majority shareholders from selling out to somebody who would take the Club in a completely opposite direction. And, whilst there's no suggestion they're going to do that it must be to everyone's advantage if a greater number of supporters own a slice of the Club.

In mid-July Arsenal announced the creation of a new corporate structure, with the separation of the club into two areas:

- (i) Arsenal Holdings plc (the new entity)
- (ii) Arsenal Football Club plc

Arsenal said that the restructuring of the club "will allow the financing of the new stadium to be put in place" and that the new company would allow the Ashburton Grove project to be separated from the normal football activities of the club. The club obtained approval from shareholders at its recent AGM.

All football clubs that list on the stock exchange have to create a plc holding company that in turn owns the football club. This is done in order to circumvent FA rules, which were designed to prevent commercialisation, but never enforced.

However, the creation of such a company is not necessarily the first step towards a stockmarket flotation, as there are other reasons why businesses restructure (tax reasons, for example). The club was reported in Sunday Business as saying that it has no "immediate plans" for a flotation. In any case, it would not appear to be a good time for the club as most football shares are performing badly.

FANS FORUM SET UP

One of the suggestions made by AISA at our first meeting with the Club – the establishment of a Fans Forum – has become a reality, with the first meeting planned for 20 October. The Forum is an ideal opportunity for fans views to be articulated and better understood by the Club.

As with AISA, the only items ruled out for discussion are matters relating directly to the team.

The principal issues of discussion are planned to be:

- Ticketing
- Stadium development
- Merchandise
- Away supporters and away travel
- Community activities
- Supporter consultation

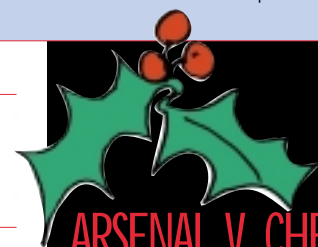
